4. Election of Board Chair for the Year 2020

4.a) (1 vote per Director)

The Manager of Corporate Administration will call three times for nominations for the position of Chair of the Board.

For each person nominated and who has consented to the nomination, an election by secret ballot will be held. Prior to the distribution of the

ballots, candidates will have the opportunity to address the Board.

If only one candidate is nominated, the Manager of Corporate Administration will declare the candidate elected by acclamation.

If only two candidates are nominated, the candidate receiving the majority of votes from the members of the Board who are present will be elected.

If three or more candidates are nominated, and no candidate receives a majority of votes, the name of the candidate receiving the least number of votes will be removed, ballots will be redistributed and the remaining candidates will stand again for election.

This process will be repeated until a candidate is elected, or until only two candidates remain and the vote is tied.

In the event of a tie vote: the names of the candidates will be written on separate pieces of paper and placed in a container. The Manager of Corporate Administration will be asked to withdraw one paper and the candidate whose name is on the withdrawn paper will be declared elected.

5.a) The process for nominating and electing the Board Vice-Chair is the same as that for nominating and electing the Board Chair.
